This is to inform that 60th Annual General Meeting (AGM) of the Members of the Company is scheduled to be held on Wednesday, the 24th September, 2025 at 11:00 a.m. (IST) through Video Conferencing (VC)/ Other Audio Visual Means (OAVM) in compliance with applicable provisions of the Companies Act, 2013 read with relevant MCA and SEBI Circulars. In this regard, kindly note the following:-

- 1. The Company is providing remote e-voting facility to all its members to cast their votes on all the Resolutions as set out in the Notice of the AGM. Remote e-voting period will commence on Saturday, the 20th September, 2025 (9:00 am) (IST) and end on Tuesday, 23rd September, 2025 (5:00 pm) (IST). During this period only those Members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. Wednesday, 17th September, 2025, shall be entitled to avail the facility of remote e-voting.
- 2. In compliance with the relevant circulars and statutory provisions, the Integrated Annual Report for the FY 2024-25 comprising the Notice of the AGM, Financial Statements along with Director's Report, Auditor's Report and other documents required to be attached thereto, will be sent to the members of the Company whose email address is registered with the Company/ Depository Participants.
- 3. The Company has already intimated the record date as Friday, 29th August, 2025 for final dividend for the FY 2024-25. The dividend, if declared at the AGM, will be paid within the stipulated period of 30 days of declaration.
