The said Interim Dividend shall be paid to those shareholders whose names appear:
 - a) as beneficial owners in the statement(s) furnished by the Depository(ies) as on the close of business hours on Thursday, 4th December, 2025 in respect of shares held in electronic form; and
 - b) as members in the Register of Members on Thursday, 4th December, 2025 in respect of physical shares
- 3. For the aforesaid purpose, the Trading Window for trading in EIL's securities has been closed from 21.11.2025 which will continue to remain close till 30.11.2025 (both days inclusive) pursuant to the EIL's "Code of Conduct for Prevention of Insider Trading and Code of Fair Disclosure of Unpublished Price Sensitive Information". The Trading Window shall re-open on 01.12.2025. Accordingly, all the concerned to whom the above said code is applicable have been requested to ensure that no trading of EIL Securities will carry out during the period of Window Closure.
