Dear Sir/Madam,

In compliance of Regulation 30 of SEBI (LODR), 2015 and in terms of sub-para 20 of para A of Part A of Schedule III and EIL's Policy for Determination of Materiality of Events/Information, this is to inform you that the Company has received Letter No. NSE/LIST-SOP/COMB/FINES/0607 dated 29.5.2025 from NSE and Email Ref.: SOP-CReview/QTR-March 2025/29.05.2025 from BSE regarding Non-Compliance with the provisions of Regulation 17(1), 17(2A), 18(1), 19(1)/19(2), 20(2)/(2A) and 21(2) of SEBI (LODR) Regulations, 2015 respectively, in respect of Integrated Governance filed for the quarter 31.03.2025. In this regard both NSE and BSE has imposed fines on the Company amounting to Rs. 13,66,440/- (inclusive of 18% GST) respectively.

It is to be informed you that EIL is a Public Sector Undertaking and all appointments including Independent Directors on the Board are made by the Administrative Ministry i.e. Ministry of Petroleum and Natural Gas, Government of India. The matter for appointment of requisite number of Independent Directors including one Woman Independent Director has already been taken up with the Government of India. In response, the Administrative Ministry has appointed/ re-appointed 4 nos. of Independent Directors as on date, accordingly, there is shortfall of 3 nos. of Independent Director which are being following up. The Company is also requesting to NSE and BSE for waiver of fines.
