I. COMPANY PROFILE

Engineers India Limited (EIL) was established under Indian Companies Act, 1956 with the objective of providing design, Engineering and related Project Management and Consultancy services for setting up hydrocarbon and processing industry plants in the country. EIL's corporate vision is "To be a Global Leader offering Total Energy Solutions for a Sustainable Future". With passage of time, EIL has forayed into new sectors like infrastructure, nuclear, power, biofuels, renewable energy, green hydrogen, water and waste water management etc. EIL is a Schedule 'A' Navratna CPSE in the Industrial Development and Technical Consultancy Services sector with the administrative jurisdiction of Ministry of Petroleum & Natural Gas. The Company employed 2656 regular employees (Executives- 2535, Non-Executives- 121) as on March 31, 2023.

Its Registered and Corporate office is at New Delhi.

The Authorized Share Capital and Paid Up Share Capital of the Company were Rs. 400 Crores and Rs. 281.02 Crores respectively as on March 31, 2023.

The shareholding of the Government of India in the Company is 51.32 % as on March 31, 2023.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Project) is a member of Board of Directors and reports to the Chairman and Managing Director. He/She has an overall responsibility for execution of Projects both as consultant as well as EPC contractor through Task Forces comprising of multi disciplinary engineering teams

supported by Services Departments and Construction Division. He/She is required to provide overall guidance, support and constant upgradation of the technical skills of the employees to match with the needs of the time and keeping abreast of latest developments. He/She is also required to maintain a close liaison with concerned Ministries, Government Institutions, Clients, Vendors, Contractors and Indian Embassies abroad.

3. QUALIFICATION:

The applicant should be an Engineering Graduate with good academic record from a recognized University/Institution.

4. EXPERIENCE:

The applicant should have cumulative experience/exposure of at least 5 years in the last 10 years in Technical/ Operational/ Project Management at a senior level of management in a major consultancy organization of repute.

Experience in project management in both domestic & overseas projects, especially in hydrocarbon sector is desirable.

- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of

appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
